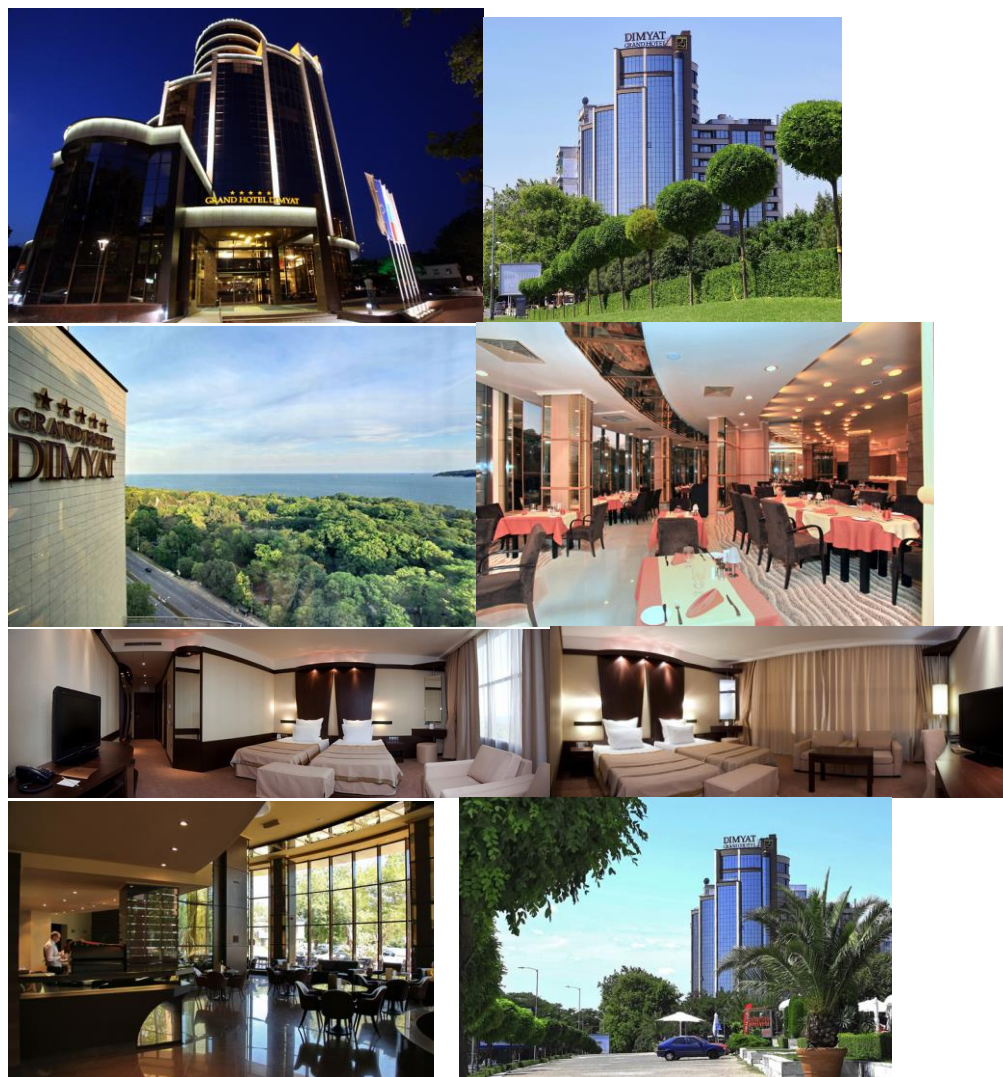

It has 6 multi-purpose halls, recreation center, fitness center, press center, a modern shopping center. The Congress Hall can be converted to a playing field (50m x 25m, 15 m in height) with an electronic scoreboard. The Mladost Complex is composed of 5 separate halls suitable for training. It has soundproofed and electronic-controlled curtains. Adjacent to the training hall is the Palace Press Centre. The complex also has two gyms, equipped with modern training equipment. The Sports and Recreation Center is furnished with equipment necessary for full recovery and rehabilitation of athletes.</p> |                         |

Each hotel room has a balcony with spectacular view of the city and the Black Sea.</p> <p>There are many restaurants and entertainment venues on the ground floor of the hotel.
