<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 30 €/per person/day.</p> <p>NOTE: In case of any medical services in the hospital, the cost must be covered by the delegation.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be uploaded by <b>March 28<sup>th</sup></b>.</p>
<b>LOCAL TRANSPORTATION</b>	<p>The LOC will provide local transportation for all participants (from/to Otopeni International Airport, from/to North Railway Station Bucharest, as well as from/to the hotel and Competition Hall.</p> <p>Transfers and international transportations will only be available to those who book accommodation directly through the LOC.</p>

Local transportation</b></li> </ol> <p><b>Four Stars Hotel 4****</b>  Single room: 105 €  Double room: 90 €</p> <p>The invited participating federations or clubs must pay for accommodation and meals expenses of their delegation members.</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates.</p> <p>While the Accommodation Form must be uploaded by <b>February 28<sup>th</sup></b> at the very latest, the costs for the accommodations must be paid to the LOC as follows:</p> <ul style="list-style-type: none"> <li>- at the time of the Definitive Entry (<b>February 28<sup>th</sup></b>) 50% of the accommodation costs.</li> <li>- at the time of the Nominative Entry (<b>March 28<sup>th</sup></b>) the remaining 50% of the accommodation costs.</li> </ul> <p><b>Cancellation/Reimbursement Policy:</b></p> <p>30% of the total accommodation costs are refundable in case of cancellations at least 1 month prior to the event (<b>March 28<sup>th</sup></b>)</p> <p>For cancelations made after <b>March 28<sup>th</sup></b> there will be <b>no reimbursement</b>.</p>
